I am e cited to appl for the Residential Counselor position at Eliot Communit Care after Name, a former Eliot emplo ee, suggested I appl . Eliot Communit Care s ork and mission are closel aligned ith m interests, as ell as m ork and service e periences. As a Peer Listener at Fen a Health, I have received in-depth training on ho to speak ith LGBTQ+ outh on a ide variet of issues the e perience, such as coming out, transitioning, and suicidal thoughts. M long-term plan is to become a licensed clinical social orker ho serves the LGBTQ+ communit , and I hope to start this journe at Eliot Communit Care.

While orking at McLean Hospital this past summer, I learned ho to approach, comfort, and facilitate conversations ith a diverse population of ps chiatric patients. As a small group discussion leader, I ensured a elcoming and safe environment for m patients to share and build communit. Because of the relationships I built, man patients chose to also come to me outside of group time to seek support in times of crisis. One patient in particular, kno n to be volatile, ould onl respond positivel to m help because of the trust I built ith her. M abilit to create genuine connections ith a variet of people and m e perience supporting patients through a multitude of challenges ill directl translate to the role of a Residential Counselor.

M time at McLean Hospital also shaped m crisis management skill. The nature of m patients serious and diverse diagnoses meant that each da as completel different from the da before, and crises ere common. On a particularl challenging da, a patient ith autism spectrum disorder as e tremel agitated and about to attack m co orker. I restrained the patient using the Handle With Care technique for almost an hour, after hich I brought him to a quiet room to console him. Through breathing techniques and talking through hat happened, I calmed m patient do n and he left the room laughing. E periences like these have prepared me to deescalate crises quickl and carefull, hich ill make me read to respond to an challenging situation that ma arise among residents at Eliot Communit. Care.

I ould consider it an honor to ork ith ou and help make a difference in people's lives. From hat I have heard and found through research, Eliot focuses on each patient holisticall, and treats patients be helping them find their inner strength. Me goal as a Residential Counselor ould be the same: I and to continue to be a positive, guiding force in people's lives.
